agreement, in which case you will not be able to use the Software.

you a nonexclusive license to use the Software, provided that you agree
to the following:

1. Use of the Software.

You may install the Software on a hard disk or other storage device;
install and use the Software on a file server for use on a network for
the purposes of (i) permanent installation onto hard disks or other
storage devices or (ii) use of the Software over such network; and
make backup copies of the Software. You may not make and distribute
unlimited copies of the Software, including copies for commercial
distribution.
